Merchandise and food vendors will be provided with one parking pass for a vehicle at the venue which will be sent to the address listed above. All merchandise and food (size, material, selling price, etc.) sold or distributed at the Regatta(s) are subject to approval by the Regatta Organizing Committee (ROC). Vendors are responsible for paying all fees, and obtaining all permits required by an federal, state and/or local government entity. ROC is not responsible for collection or submission of any such government fees or filings. Please call Jason if you wish to use PayPal for paying your registration fee. There will be a \$50.00 charge if ROC needs to clean up your area after the event. Distribution, layout or hanging of any items outside of the designated booth area is not permitted. All vendors need to be registered and paid seven days before the event. Registration fee must accompany this form. ROC may refund any registration fee for any Regatta at their discretion. All booths must be setup between 3PM and 7PM on the 8<sup>th</sup>, before noon on the 23<sup>rd</sup> and May 7<sup>th</sup>. Booths must be staffed and not broken down until one hour after the last event. Night security will be provided but the ROC and the Regatta organization will not be responsible for any issues that may occur at a booth during the event.

**\*\*The Vendor Certificate of Insurance should include:**

In the "Description of Operations/Special Provisions" section: Sarasota County Government, the Friends of Sarasota County Parks, the Regatta Organizing Committee, and Florida Scholastic Rowing Association shall be named as an additional insured, as their interests may appear on all policies except Professional Liability and Workers' Compensation. Waiver of subrogation in favor of Sarasota County Government, Friends of Sarasota County Parks, Inc. and Regatta Organizing Committee, on all policies except Professional Liability and Workers' Compensation. In the "Certificate Holder" section add in Sarasota County Government, Attn: Risk Management, 1660 Ringling Blvd., 3<sup>rd</sup> Floor, Sarasota, FL, 34236 and Friends of Sarasota County Parks, 6700 Clark Road, Sarasota, FL, 34241. If a full contract has been initiated through Procurement the "Notice of Cancellation" must be 30 days per contract provisions, with 10 days for non-payment of premium added if necessary. The lowest of County limits are required at \$500,000 per occurrence General Liability including Products and \$500,000 per accident auto liability. Vendors do not have to provide Workers' Compensation nor umbrella. \*\*\*If you are not vending for FSRA event, they do not have to be included in insurance\*\*\*

Vendor(s) agrees that it shall indemnify, defend and hold harmless the Regatta Organizing Committee, Friends of Sarasota County Parks, Sarasota County, and the Florida Scholastic Rowing Association, its officers, volunteers, directors, agents, successors and assigns from and against any and all losses, costs, claims, damages and expenses (including attorney's fees) arising from or related to vendor(s) actions, business activity, booth, advertising or otherwise arising from or related to vendor's participation in the subject event. In addition will further hold harmless the above from any and all losses, direct or consequential, arising from or related to cancellation, postponement, delay or rescheduling of the subject event, regardless of cause.

\*\*\*No merchandise using FSRA names (FSRA, Florida Scholastic Rowing Association, Florida State Championship Regatta) or logos may be sold at the FSRA event without signed contract from FSRA, otherwise said merchandise is subject to forfeiture.
